### **Cyber Hacks - Tax Phishing Scam**



Tax season is also the time when phishing agents look forward to a whole lot of good catches. Phishing baits are sent out as emails to many recipients, many of whom fall for it, leading to a catastrophe. Malicious actors use the information to defraud the victim or even steal their identity.

The IRS does not initiate contact via email, text message, or use social media channels; they do not demand, make threats, or ask people for PIN numbers, passwords, or other personal information for their credit card, bank, or other financial accounts.

#### Tips to keep in mind If you receive a suspicious email claiming to be from the IRS:

- Use a secure internet connection (HTTPS) if you file your taxes electronically.
- Don't click links or attachments in an unsolicited email or text message about your tax return.
- The IRS will not call you threatening legal action. If you receive a call like this, hang up immediately.
- Report suspicious phone calls, faxes, text messages and mailed letters to phishing@irs.gov.
- Report suspicious IRS email charges received to your work email, using the Report Phishing Cofense button located in your Outlook toolbar.
