## Cyber Hacks: New **Warning Alert** for External Emails

Brink's Global Information Security recently implemented an email banner for all emails received from outside Brink's domains. The main purpose of this banner is to **reduce the likelihood of a successful phishing attack** received by email. It will alert users that the email is from outside the organization and remind them to be cautious of opening attachments or clicking on links that come from external and unknown contacts.

### New! **Caution Banner for all External Email:**



The new banner provides a clear distinction between internal and external email senders and provides awareness to help you decide whether the email is legitimate or suspicious. If an email contains a suspicious request or tone, it is best to **report it using the 'Report Phishing' button located in the Outlook tool bar**. When in doubt, it's best to report it!

### Additional **red flags** in suspicious emails:

1. Grammar errors or inconsistent subjects and content
2. Sender or the content request is not usually a part of the normal process
3. Branding, logos, and business terms are incorrect

## Thinking Resilience: This is National Preparedness Month

**National Preparedness Month** takes place every **September**. It serves as an annual reminder to revisit our event response planning. How prepared are you to respond in a disaster? Do you have immediate access to contact information for internal and external support? Considering the emergency supplies you have on-hand, are you able to sustain your employees on site for at least three days after a disaster? Are you thinking about long-term as well as short-term needs?

One critical concept is the importance of establishing key relationships and partnerships in "blue sky times" before a disaster strikes. These kinds of collaborative partnerships are integral to achieving resilience in disaster. ***This September, take a moment to evaluate your preparedness and see if you can strengthen it with key partnerships.***

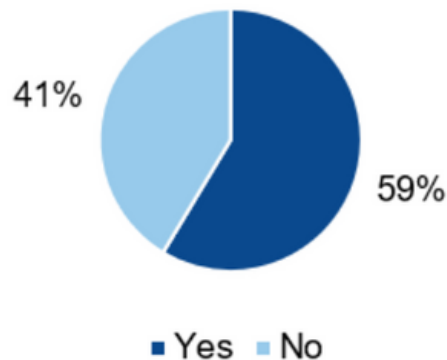

## Cesar Chavez (1927 - 1993)

Cesar Estrada Chavez was an American labor leader, community organizer, businessman, and Latino American civil rights activist. He co-founded the National Farm Workers Association, which later became the United Farm Workers labor union.

## Ellen Ochoa



Ellen Ochoa became the first Hispanic to leave Earth's atmosphere in 1993. Ochoa went on to become the first Hispanic director and second female director of the Johnson Space Center.

## Antonia Novello

Antonia Novello was the first woman and first Hispanic to ever be appointed Surgeon General of the United States (1990-1993). After leaving the post of surgeon general she became a representative for the United Nations Children's Fund (UNICEF), where she continued to address women's and children's health issues.

Luis Von Ahn developed the cyber-security system CAPTCHA and reCAPTCHA. CAPTCHA (Completely Automated Public Turing test to tell Computers and Humans Apart) is a randomly generated challenge-response test designed to help stop spam bots from accessing computer systems.
