Cyber Hacks - Reporting a Cybersecurity Issue



If you believe a cybersecurity issue has occurred, it is important to report it as soon as possible. This allows the investigative team to act quickly to determine the level of impact and contain the issue. It is critical that cybersecurity events are investigated where we have an obligation to external entities to report, these could include: personal data, client confidential data, financial data, etc.

How to Report:

Immediately report the possible issue by **one** of the following methods:

- Opening a ServiceNow ticket
- Calling Brink's US Helpdesk support at +1-877-741-5773
- Emailing the Global Information Security team at GIS@brinksinc.com

What Information to Include in the Report:

- Contact information
- Brief description of what happened
- General description of the type of information involved (Personal, Customer or Financial data)
- General description of the impact of the issue, if known
- Provide any additional known resources affected
- If the issue involves a lost or stolen mobile device, provide the police report number
