# **Covid-19 Vaccinations Are Free and FDA Approved – Get Your Shot Today!**



The U.S. Government has directed federal agencies to require employees performing work under or in support of federal contracts and working in a location with covered contract employees to be fully vaccinated and comply with CDC guidance for the wearing of masks and social distancing in high transmission areas. Additionally, a similar executive order requires employees of businesses with more than 100 employees to be fully vaccinated or enter a weekly testing protocol.

**Brink's is a Federal Contractor** because of the services we provide to a broad variety of federal agencies and entities.
