Cyber Hacks: Whaling Phishing Attacks



A whaling attack is a type of phishing that **targets executives of a company**. In a whaling attack, hackers utilize social engineering to deceive targets into disclosing sensitive information such as bank account numbers, customer information, or credit card numbers. Another common strategy is to request a wire transfer from the executive's company email account.

How to Defend Yourself:

- **Cyber Security Awareness Training:** Brink's offers security awareness training as well as phishing simulation activities to help improve awareness of the most recent attack strategies.
- **Monitor Incoming Email:** If an email appears suspicious, even if it is from someone you know and has an urgent request, it is recommended to report it using the Report Phishing Cofense button in your Outlook toolbar.
- **Be Wary of Email Links:** Hover your mouse cursor over any suspicious link to see the URL where it takes you. It is advisable to go directly to the website on your own, rather than the link.
- **Protect Sensitive Information on Social Media:** When possible, set privacy settings on your social media accounts and minimize the information you disclose about your job or personal life. Attackers often search victims on social media.

Insights: Diversity & Inclusion - Choosing your Words

An essential tenet of a workplace that champions diversity and inclusivity is a **sense of trust and respect**. Part of that is acknowledging that each team is filled with unique individuals of different genders, ethnicities, generations, religions, and sexual orientations.

Learning terms and familiarizing yourself with the history behind them helps show that you are **genuinely invested in your team's diversity**, each member's inclusion, and creating an environment of mutual trust and respect.

Try This: If you're unsure what terms a team member prefers, ask! Politely asking colleagues how they prefer to be addressed or what terms they'd like you to use is a simple and effective way to show them that you respect their identity.

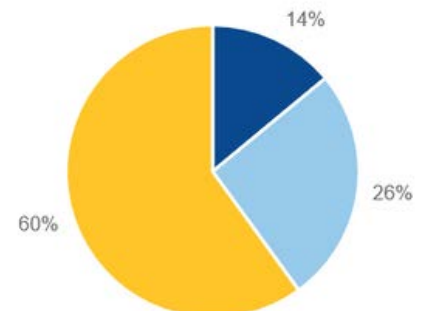
