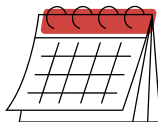

As a reminder, we encourage everyone to **Be Cyber Aware** and consider the importance of cybersecurity.

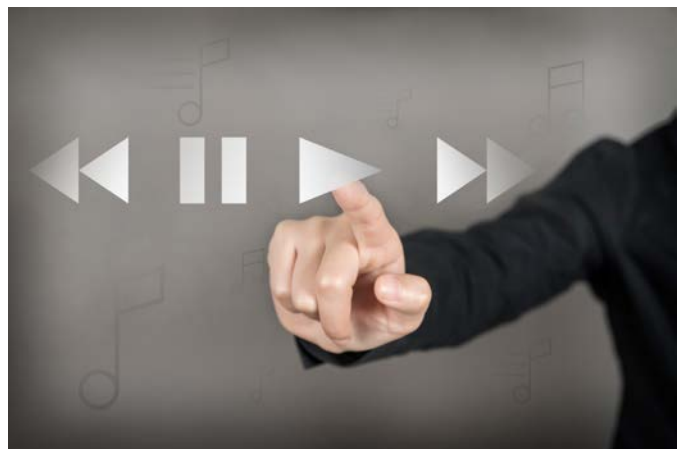

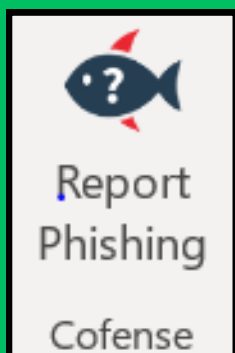
