## **Save the Date: Black History Month Special Event**



## **Cyber Hacks: What is Open Source?**

'Open source' refers to software programs whose **source code is freely available for users to view, modify, and distribute.** When it comes to company data, the dangers of using open-source tools include potential security vulnerabilities, lack of official support, and outdated security updates. As a result, these vulnerabilities can cause malware to enter the supply chain at any point, from initial code contributions to the final product. An attacker can take advantage of a single component in the chain, compromising the entire system and putting sensitive data at risk.



### There are two major risks with using open-source tools:

- **Vulnerabilities.** These may include known vulnerabilities, vulnerabilities inherited from other libraries, vulnerabilities that have been fixed but reappear because of library versioning, and zero-days and half-day vulnerabilities about which little is known, making it possible for criminals to exploit them more easily.
- **Malware.** Sophisticated attackers are now using simple techniques to create libraries that appear to be innocent but contain malicious code.


