HOW TO VIEW YOUR 1095-C IN WORKDAY

From your **Home Dashboard** in Workday:

- 1. In the Search Bar type My ACA Forms
- 2. Click the "Report" button
- 3. Update your 1095-C Printing Elections: Click the **Change 1095-C Printing** Election button
- 4. Select one of the available radio button options and click "Ok" at the bottom of the page
- 5. Select the "View/Print" button for the appropriate tax year
- 6. Follow the on screen prompts for delivery

As we continue our transition from Okta to Microsoft (MS) Azure AD, **you are required to set up Multi-Factor Authentication (MFA)** to continue accessing your corporate apps – and it's time to do that now.

You can complete the sign-in process using the same credentials (username/password) that you used to login today.


Cyber Hacks: Beware of Insider Threats



A insider threat refers to situations where employees, without malicious intent, inadvertently compromise security protocols or expose sensitive information.

Examples of unintentional insider threats include:

- 1. Falling victim to phishing emails or social engineering tactics, which leads to unintentional disclosure of login credentials or sensitive data.
- 2. Accidentally clicking on malicious links or downloading malware, which can compromise our systems.
- 3. Sharing of sensitive information with unauthorized individuals or on insecure platforms, due to lack of awareness of proper data handling procedures.



Tips to help avoid unintentional insider threat:

- 1. Be vigilant and cautious when handling emails, especially those requesting sensitive information or containing suspicious links or attachments.
- 2. Regularly update passwords and use a strong, unique passphrase.
- 3. Verify the authenticity of requests for sensitive information, especially if they come from unfamiliar sources or seem unusual.
- 4. Always adhere to company policies and procedures regarding data handling and security protocols.

Celebrating the Arts During Black History Month



Edmonia Lewis (1844-1907)

Edmonia Lewis was an American sculptor who worked in a Neoclassical style creating detailed marble sculptors. Her themes included stories from classical antiquity as well as from the lives of Black and Native American people. She exhibited at the Philadelphia World's Fair in 1876 and was later commissioned by former President Ulysses Grant to sculpt his bust. Today, her marble sculptures are found at the Metropolitan Museum of Art and Smithsonian and achieve hundreds of thousands at auction.

Gordon Parks (1912-2006)

Gordon Parks was one of the first photojournalists and film directors to honestly capture the Black experience in photography and film. He was hired by the Farm Security Administration (FSA) to photograph American life during the Great Depression and he focused especially on African Americans. He would later become one of the first Black fashion photographers for Vogue and was later hired by Life, where he wrote and photographed essays, and co-founded Essence magazine.

Faith Ringgold

Faith grew up in Harlem in the midst of the Harlem Renaissance, of which the art, music, and literature would inspire her work. She actively dealt with issues of racial injustice and feminism through her paintings and murals, but by the 1980s she moved away from these mediums into quilting. Now in her 90s, Faith Ringgold is represented in many major museums like the Guggenheim and MoMA.
