#### Here is what employees can expect from Brink's during investigations and what we ask of you in return:



**Confidentiality:** To the extent possible and required, all parties shall maintain confidentiality throughout the investigation.



**Fairness and Respect:** All parties will be treated with fairness and respect. Employees will be given the opportunity to provide perspective and evidence in a safe and unbiased environment.



**Cooperation:** Employees must cooperate fully with investigators and provide accurate information.



**Transparency:** Brink's will provide transparency with regards to the investigation process and timeline.



**No Retaliation:** Brink's strictly prohibits any type of retaliation against those who report in good faith.


#### Recommended Items:
