## **Total Solar Eclipse Coming on April 8: Get Your Glasses!**

On **Monday, April 8, 2024**, a total solar eclipse will cross North America, passing over Mexico, the United States, and Canada. The total solar eclipse will begin over the South Pacific Ocean.

Please check the map from NASA in the link to see if you are in the path of totality and check for plans in your city for schools or highway closings or viewing parties.

### **Okta Transitions to Microsoft Azure**

Over the next week or so, we will transition to Microsoft Azure for identity verification and app integration, and begin to phase out the Okta solution. Workday is the first company application that will require your Microsoft Login instead of Okta, on Thursday, March 21.



To sign in to Workday after the transition to Azure, please follow the steps below:

- 1. Access Workday Application by going to *https://myapplications.microsoft.com* or using the direct link in the Quick Links Box below.
- 2. For sign in, use your **[email prefix]@brinks.com** as the username and enter your email password. **Please Note:** this may be different than your email address. For example: *first.lastname@brinksinc.com* would use *first.lastname@brinks.com* to log in.
- 3. You will be required to do Microsoft Multi-Factor Authentication (MFA). Follow the instructions below if you haven't already registered for Microsoft MFA.

**Multi-Factor Authentication Requirement (MFA) –** You will be required to complete Microsoft Multi-factor Authentication to access Workday application. If you haven't already registered for Microsoft MFA, you can do so by using the link below. A step by step guide to complete the MFA registration is provided in the Quick Links box below.

### **Cyber Hacks: Understand Credential Stuffing Tactics**



Credential stuffing is a cyberattack method in which attackers use lists of compromised user credentials to breach into a system. The attack uses bots for automation and scale and assumes that many users reuse usernames and passwords across multiple services.

The attacker monitors for successful logins and obtains personally identifiable information, credit cards or other valuable data from the compromised accounts. Additionally, they retain your account information for future use.

#### How to protect your data from credential stuffing attacks:

- Actively monitor failed authentications and track them over time.
- Use Multi-Factor Authentication (MFA) to add another layer of security.
- Don't use the same password or passphrase across work and personal accounts.
- Verify the legitimacy of any unsolicited/unexpected emails before you interact with them.
- Report every suspicious email with the 'Report Phishing' Cofense button in your Outlook.









**Ibtihaj Muhammad**
